### I. CALL TO ORDER/ROLL CALL

Pursuant to notice, a special meeting of the Sedona Fire District (SFD) was called to order by Chair Helen McNeal at 1:01 PM on Tuesday, November 12, 2024. Kim Smathers recorded the minutes. A quorum was present, and the meeting, having been duly convened, was ready to proceed with business.

Chair McNeal led the Pledge of Allegiance and a moment of silence for all service members and first responders.

#### II. NEW BOARD MEMBER ORIENTATION

A. <u>Discussion/Possible Action: Orientation and Introductions for New Elected Board Members</u>

Chair McNeal welcomed the newly elected Board members Lance Waldrop and Diana Christensen and stated that this would be an informal meeting to place faces to names and for outgoing Board members to share their knowledge and experiences. Chief Mezulis stated that present from Sedona Fire were the two labor groups, the 3690 and ASEA and members of the executive team. Each person introduced themselves and their position.

Mr. Whittington presented the Board with paperwork regarding statutory training requirements, Board duties and responsibilities, Open Meeting laws, violations, and punitive damages, uses for Executive Sessions, and other required information for new Board members. He encouraged them to attend Arizona Fire District Association Winter Conference in January to receive their statutory training.

Chief Mezulis briefed on current projects ongoing at SFD, including a follow up meeting with the City of Sedona, communications systems upgrades, upcoming budget season, and Meet & Confer.

The members will be sworn in on December 17 and then will be seated at the January Board meeting.
